SUPPLEMENT 1: COMMERCIAL ITEM PROCUREMENTS  
U.S. GOVERNMENT CONTRACT PROVISIONS FOR COMMERCIAL ITEMS

The following Federal Acquisition Regulation (FAR) and Defense Federal Acquisition Regulation Supplement (DFARS) clauses (if the Order is funded by Department of Defense) are each incorporated in and made a part of the Order. In the below listed clauses, the term “Contractor” shall mean “Seller,” the term “Contract” shall mean “Order,” and the term “Government Contracting Officer,” or equivalent phrases, shall mean “Buyer.” It is intended that these clauses shall apply to Seller in such manner as is necessary to reflect the position of Seller as a subcontractor to Buyer, to ensure Seller’s obligations to Buyer and to the United States Government, and to enable Buyer to meet its obligations under its prime contract.
